## **Hazard Statements**

May be fatal if swallowed and entered airways. Causes skin irritation. Harmful if inhaled. Causes serious eye irritation. May cause an allergic skin reaction. May cause drowsiness or dizziness. ### 4. FIRST AID MEASURES

**Inhalation:** Remove patient to fresh air. If not breathing, give artificial respiration. Give oxygen as necessary, if qualified personnel is available. Get medical attention if necessary.

**Eye:** Flush with a large amount of water for at least 15 minutes, lifting eyelids until no evidence of the chemical remains. Get medical attention. Remove contact lenses, if present and easy to do. Continue to rinse.

Skin: Wash skin with plenty of water for at least 15 minutes. Wash contaminated clothing before use. Get medical attention if necessary.

**Oral:** Rinse mouth. Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Call a POISON CENTER/doctor/physician if you feel unwell.

### 5. <u>FIRE FIGHTING MEASURES</u>

Suitable Extinguishing Media: Alcohol resistant foam, Dry chemical powder, Carbon dioxide (CO2)

Unsuitable extinguishing media: Do not use a heavy water stream. Use of heavy stream of water may spread fire.

## 6. ACCIDENTAL RELEASE MEASURES

**Storage Conditions:** : Store tightly sealed in a clean, dry place, and well ventilated place. Do not store in temperatures that exceed 125°F/52°C. Avoid strong acids, strong bases and strong oxidizers.
